Sir/ Madam,

I am directed to state that the Postgraduate Medical Education Committee of this Council at its meeting held on 07/03/2018 considered the Compliance Verification Assessment Report (15/01/2018 along with the Council Assessor's Report (July, 2016) and compliance dated 06/02/2017 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(DVL) qualification for 2 seats at Bankura Sammilani Medical College, Bankura granted by West Bengal University of Health Sciences, Kolkata and decided as under:-

*"The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (15/01/2018 along with the Council Assessor's Report (July, 2016) and compliance dated 06/02/2017 submitted by the college authorities and decided to recommend to the Central Government that MD(DVL) qualification for 2 seats granted by West Bengal University of Health Sciences, Kolkata in respect of students being trained at Bankura Sammilani Medical College, Bankura be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.*

*The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."*

You are therefore requested to notify the above qualification at the earliest.
